Report of the President

Presented at the YANKEE GRC Annual Meeting, January 28, 2006

elcome to the Annual Meeting of the YANKEE GOLDEN RETRIEVER CLUB.

This year, as we started last year, we are providing written copies of the committee reports. Unfortunately, as last year, the President doesn't get to just hand in a written report. So you will have to bear with me while I briefly try to sum up our year.

Let me start by first thanking Donna Morgan, Melanie Porter, and their helpers for once again arranging our spectacular dinner & meeting. Donna and Melanie, thank you very much for the great job.

2005 was another successful year for **YANKEE**, because you were *great*! It is you, the members that make **YGRC** one of the best breed specialty clubs in the country. So give yourselves a round of applause and a pat on the back. Now let's get to work, because we can't rest on our laurels and a new year has already started.

The *Potomac Valley Golden Retriever Club* did a superb job. **YANKEE**'s task is to equal Potomac Valley's performance and hopefully go them one better.

So roll up your sleeves and let's get to work. Don't wait to be asked to help, *volunteer now*! And don't forget that just because we are doing the National in 2008 doesn't mean that we can slack off on our regular events in the meantime. Thank you all!

YANKEE GRC Membership

The application procedure to become a voting member of **YANKEE GOLDEN RETRIEVER CLUB** is as follows:

1. Prospective members must attend two **YANKEE** meetings prior to becoming eligible for a full, voting membership. Club meetings are on the fourth Tuesday of odd-number months, earlier in November, usually at the Acton Congregational Church. Copies of the club constitution and Bylaws are available at each meeting.

2. A completed membership application, signed by two **YGRC** members in good standing, and the membership dues for one year must be submitted to the membership chair.

3. Upon completion of the membership requirements, the membership chair will present the application for a vote at the next club meeting. All membership requirements must be completed within one year of application, or the application will expire and must be resubmitted.

Non-members can subscribe to the **YANKEE GRC** newsletter, *Finish Lines*.

Complete the front page of the member– ship application and send it with the fee of \$25 to the membership chair.

Please note: Article 1 of the **YANKEE** bylaws states in part: During the month of November, a dues statement, payable on the first of February of the following year, shall be mailed to each club member. No members may vote who have not paid their dues for the current year. A membership will be considered as lapsed and automatically terminated if a member's dues remain unpaid 90 days after the first day of the fiscal year, *i.e.*, April 1. A \$10 late fee will be applied to any payments made after February 1.

Lapsed memberships are ineligible to vote, receive trophies, list wins in *Finish Lines*, list litters with Breeder Referral, *etc.* To re-join the club, the complete procedure described above must be followed.

Sandy Sonntag Memorial Trophy

The Sandy Sonntag Memorial Trophy is awarded to a member of the YANKEE GOLDEN RETRIEVER CLUB who has performed exemplary service to the Golden Retriever breed and/or their community. This accomplishment could have been an outstanding one-time act or cumulative months of service. Each year club members are invited to nominate members who they feel have given of themselves for the breed. The board then reviews the nominees and makes the final decision.

This year's recipient of the Sandy Sonntag Memorial Trophy is someone who has dedicated herself to Golden Retrievers. She's someone many of us have worked with and all of us admire completely: Joy Viola.

Joy is currently the Director of Development & Planned Giving for the Golden Retriever Foundation and serves as a financial development consultant for GRCA National Rescue Committee, and previously was one of the financial wizards in the success of Yankee Golden Retriever Rescue. For more than a decade Joy has been successfully raising capital to benefit our wonderful breed.

A little background about Joy and her work with Golden rescue. You know that Yankee Golden Retriever Rescue is one of the most successful breed rescue groups in the country. It's grown from a small band of dedicated volunteers, scrambling for resources, into a well-funded organization with a permanent home. That happened in 1996 when, after the conclusion of a successful capital campaign directed by volunteer Joy Viola (with her husband, Alfred), YGRR was able to purchase Riverview, in Hudson MA. Joy (and Al) not only directed the campaign, but were also donors to it. In 1998 a new capital campaign was begun to expand the existing kennel facilities. Through Joy's efforts as the volunteer capital campaign director YGRR raised more than \$1.6 million. Thanks to Joy's determination and dedication, and the generous support of YGRR's many friends and members, the Rescue Goldens now occupy a state-of-the-art facility while they await permanent new homes.

Joy has continued her work on behalf of Goldens as Director of Development and Planned Giving for the Golden Retriever Foundation. Some of you may have seen the GRF's wonderful video, "In Support of a Golden Cause," which was nominated this year for an award by the Dog Writer's Association of America. Joy oversaw production of this video, wrote the script and gathered the photos.

Joy works tirelessly for the benefit of Golden Retrievers. Her efforts benefit the breed we love, and Joy is an inspiration to all of us to match her dedication. On behalf of **YANKEE GOLDEN RETRIEVER CLUB**, it is a pleasure to recognize and present the Sandy Sonntag Memorial Trophy to Joy Viola.

Annual Committee Reports for 2005

Agility (Karen Frink)

Not willing to reinvent the wheel for this report, I went back to last year's report to see what I'd written. I thought for a brief moment about changing the dates in that report and being done with it, but that would've been cheating. I figured I might get away with it, since most of the same people do the same help year after year. That made me think back to the first agility trial YANKEE



did in September 1997. I think there were maybe five club members who actually had a dog entered in the trial, but *many* other members came out to help and to see what all the fuss was over this relatively new sport. This seems to be typical of the **YGRC** membership — always willing to help out — just like a Golden.

YANKEE held six agility trials this year, two days in July, and the four days at the Bay Colony Cluster in Boston in December.

The July trial was held indoors at the Sports Zone in Derry NH again this year. It's great to have an indoor airconditioned venue in the heat of the summer. The owners of the Sports Zone were so impressed with the club as well as the agility competitors in general, that we've been invited back to hold the trial again this year. **For 2006**, the Derry trial dates are July 8 & 9; the judges will be Monica Land and Jean MacKenzie.

The December trials in Boston is New England's grand finale of the agility season and they were a huge success. We even managed to have the requisite snowstorm on Friday not quite the blizzard of 2003, but nonetheless exciting and challenging for the commute home. **For 2006**, the Boston trial dates are December 7–10; the judges will be Barbara Diaz (Thu & Fri) and Edie Allyn (Sat & Sun).

All the successes that **YGRC** has with the agility program are due solely to the hard work and effort by many club members. We had pretty much the same crew for all six trials. We all know what our jobs are, so our agility committee meetings last about a minute or so: "Are we all doing what we did last time? OK, good. Meeting adjourned."

Breeder Referral (Barbara Lukis)

S tatistics for breeder referral: 31 breeders and 44 litters went through breeder referral last year.

Clinics (Jan Bramhall)

Each year, **YANKEE** runs health clinics — eyes and heart — in the spring and fall.

This year, the eye clinics were at Concord Animal Hospital with Dr. Donovan:

- Spring clinic: 32 exams
- Fall clinic: 55 exams

Thanks to **YGRC** members Arlee Recktenwald, Deirdre Doyle, Carol White, and Ann Houston for taking charge of things.

The fall. heart clinic was at Shepard Veterinary Clinic with Drs. Mark Stamoulis and Paul Kaplan. We did 142 exams. Thanks to **YGRC** members Denise Page-Eugene and Donna Cutler for helping.

Field (Judith Erlanger)

The YANKEE field committee's year begins in January and February with preparations for the annual classes, which were well attended in 2005. We had 9 dogs enrolled in Fundamentals, 12 in the JH/WC class, and 16 in the WCX/JH class. Our instructors were Carol White, Bunny Millikin, and Sally Bridges, and we have a new class coordinator, Judith Erlanger. The breeds represented in our classes: were Golden Retrievers, Flat Coated Retrievers, Irish Water Spaniels, and Chesapeake Bay Retrievers.



We started our move into the 21st century by using email for all correspondence with class participants. For 2006, we plan to put the field class enrollment forms on-line, and use postcard notification for club members and interested friends with other retriever breeds.

Special thanks go to Andrea Fisher, out-going class coordinator, for her many years of service to the field contingent.

The clean-up day at West Thompson drew 12 retriever people representing YGRC, North East Flat Coat Retriever Club, Colonial Field Trial Retriever Club, Yankee Waterfowlers, Labrador Retriever Club of Greater Boston, Chesapeake Bay Retriever Club, and Shoreline Retriever Club. We built an enclosure for a new porta-potty which will be in Alice's Field. The point of having retriever people attend the clean-up event was to put a face - or faces - on the "dog people" who use the property. YANKEE members in attendance were Mary Sharkey, Claudia Norton and her husband and daughter, Rhonda Jarman, Theresa Stremlau, and Judith Erlanger. We want to get more people down to the event next year, since dozens of Boy Scouts and Cub Scouts were there who probably don't use the property as much as we dog people do. Maybe we'll have to offer a merit badge for field people!

YGRC held its Spring WC/WCX and Singles/Puppy Stakes on May 7 at West Thompson, and despite horrendous weather, the tests were well attended. The judges and workers were real troupers for enduring the harsh conditions. Andrea Fisher and Charlie DeMarco did a wonderful job as co-chairs. Dawn Terrill and Karen Scotti set up very fair WC/WCX tests, as did judges Dick Kennedy and Judith Erlanger who judged the Singles stake, and Dick Kennedy and Patti Sullivan (who stepped in last minute) to judge the Puppy Stake.

Special thanks to all those who worked at the various stakes, and the gunners who made shooting the birds look easy — it is not!: *Gunners*: Alex Cook, Ralph Halvorsen, and Nick Staszko; *bird boys*, marshals, stewards: Nancy Ford, Pat and Randy McKinney, Kate Horgan-Burke, Jonathan and Linda Rausch, Roseann Mandell, Diane & Steve Brunelle, Marcia Pierce, Jill Moffett, Rhonda Jarman, Charlie Lanagan, and Patti Sullivan; *secretary and equipment*: Barb Sawtelle, Bill Caron, and Carol White; *hospitality*: Sheri & Bill Caron.

This year's **hunt test** was chaired by Patti Sullivan, Carol White and Donna Morgan. Barb Sawtelle was the secretary for the event, handling the paperwork and the visit from the AKC rep flawlessly. Ken Lukis managed the responsibility of gun captain beautifully. Rhonda Jarman and Charlie DeMarco moved equipment, and Sheri & Bill Caron did an absolutely incredible job in hospitality. When Bill wasn't in the kitchen, he was in the field moving equipment, delivering food and ice and doing anything that needed to be done. Huge thanks to our very capable marshals,. Pat Scribner, Karen Scotti, who worked as marshals and everywhere else they were needed at Master for two days; Denise Ryan who skillfully ran the Senior stake, and Jill Moffet and Charlie Lanagan who handled the Junior stakes.

In addition to our marshals, we want to thank the dedicated folks who served as stewards, poppers, bird boys, blind planters, and all-around help. Thank you to Roseann

The AKC rep was very impressed that we had our own on-site vet. Thank you, Mike, we owe you!

The Fall WC/WCX tests, chaired by Karen Scotti and Bill Caron, were held on a glorious October day at the West Thompson Dam — the clear skies and brisk fall air was perfect. Our judges, Arline Buchanan and Ken Kogut, planned well designed tests and were a pleasure to have with us. Our judges for the puppy stakes, Diana Cooper and George Smilas, and everyone else were gleefully entertained by the antics of the budding, young field stars and their creative handlers. A big thank you for everyone who helped during the day and special thanks to Sheri Caron for the wonderful food, Ken Lucas for serving as gun captain, Jonathan Rausch for assisting with equipment, Rhonda Jarman for marshalling, and Roseann Mandell and Jean Deresienka for stewarding.

As always, **YGRC** has the very best volunteers to make all our events fun and successful. But it's apparent that many of the same people volunteer to work at **YANKEE**'s field events, giving both their time and experience to help perpetuate the retrieving instinct in our breed. We're always looking for help for field events, so please consider coming out to help in 2006. Without the help from our members and friends, we can't offer the events we all love to do with our dogs. See you out in the field!

Tracking (Ray Desmarais)

ANKEE tracking held four events in 2005. In the spring we held a two-day TDX seminar on one weekend followed by a oneday beginner seminar the following weekend. Both seminars filled with dog and handler teams along with a number of observers. Thanks



to Kathy Goodman and Amy Deutsch for putting the seminars together and handling the hospitality. A special thanks to Robin Prouty for the use of her property for both seminars.

In August, we held our third **VST test** on the campus of the University of New Hampshire. The test filled with all Goldens. This year, 92 puppies went through PK, and 31 went through Post Grad, for a total of 123 eager students and their two-legged companions. People came from as far as New Hampshire and all the way up from Rhode Island. There were a couple of families that were brave enough to have two puppies at once. One family was so determined to train their pup, "Annie," they actually went through PK and three sessions of Post Grad. This year, the most popular name for a girl pup was "Abby" and the most popular name for a boy was "Brady" (gee I wonder why).

For 2006, we started classes on January 5 and are hoping for another successful year.

Finish Lines newsletter (Geoff Stern & Roseann Mandell)

Finance (Pat Lindquist)

Legislative watch (Judith Erlanger)

YANKEE has become more involved in preserving our rights as dog owners, breeders and in performance events. We have a **YGRC** member on the board of directors of the Massachusetts Federation of Dog Clubs (MassFed) and Responsible Dog Owners. We had two **YGRC** members, Patti Sullivan and Judith Erlanger, attend MassFed's first lobby day in April. at the State House.

In June, MassFed successfully fought a breeder licensing bill in Massachusetts with help from **YANKEE** members who contacted their legislators — and one member who testified at the bill hearing. **YGRC** also took a position at the federal level in opposition to the PAWS legislation proposed by Sen. Rick Santorum (R-PA). The bill is still pending.

In the spring. MassFed filed a bill to require quarantining the thousands of stray and feral dogs being imported into Massachusetts shelters. In April, MassFed's efforts resulted in the emergency orders issued by the MA Department of Agriculture requiring a 48 hour quarantine of dogs imported into the state, and the August orders regarding the Hurricane Katrina dogs. The hearing on this bill was held in December, with MassFed members present to testify in support. Judith Erlanger testified on the new tick-borne diseases that have proliferated in Massachusetts, which were brought here by the dogs imported from the southern U.S. and offshore islands.

The members of Mass Fed's Board of Directors would like to thank the members of **YGRC** for their support in contacting their legislators and for the financial donation that helped pay for MassFed's Lobby Day.

The American Kennel Club was founded on September 17, 1884 by twelve dedicated sportsmen. The founders represented dog clubs that had recently held either a field trial or benched dog show. Their goal was to use field trial events as a performance standard by which to test one dog against another. Hunt tests were developed in 1985 to offer hunters during the off hunt season the opportunity to evaluate their dogs in a hunting scenario. AKC hunt tests have proven to be an excellent means to introduce new handlers to the challenge of retriever competition in a hope that they would advance into field trials. AKC field trials have evolved technically, and so must the Golden Retriever. Highly competitive field trials are the highest measure to evaluate a retriever's abilities and performance.

The advancement and promotion of Golden Retrievers in field trials must be given higher priority to keep the Golden Retriever from field trial extinction. The Golden Retriever is a sporting breed and retrieving is it's purpose. A Golden Retriever with an FC or AFC has reached the highest level of accomplishment with these honorable titles. The advancement and promotion of the Golden Retriever's natural abilities in Field Trials should be the absolute goal following health concerns.

The Golden Retriever Club of America code of ethics maintains that the Golden Retriever is a gun dog and that all must be done to advance, promote and perfect the inherent abilities of this breed.

The AKC official standard of the Golden Retriever implies that the Golden Retriever is primarily a hunting dog and departure from the breed's purpose is a serious fault.

The Golden Retriever Club of America bylaws recognizes that the Golden Retriever is a gun dog and that members should promote and advance the perfection of those qualities. It is to this end that the GRCA bylaws have made field trials at the annual GRCA National a mandatory event requirement.

AKC-licensed retriever field trials are the major leagues for working retrievers.

The very first winner of the United States National Open Retriever Championship was a Golden Retriever named NFC *King Midas of Woodend* in 1941. The last Golden Retriever to win the National Open Retriever Championship was NFC *Ready Always of Marian Hill* in 1951. From 1957 to 2005 only one Golden Retriever has won the United States National Amateur Retriever Championship, NAFC/FC/AFC *Topbrass Cotton* in 1985. Currently in the northeast the Golden Retriever is represented at Field Trials with only 5% of total entries. The accomplished field trial Golden Retriever breeding stock is dangerously small. Only a handful of truly dedicated Golden Retriever handlers and breeders are trying to hold back this breed's extinction from field trials. The Golden Retriever does not have to face this demise. Steps can be taken now to reverse this trend.

Improve the Golden Retriever by requiring that every Conformation Champion meet a field standard by acquiring a minimum of either Senior Hunter or a Judge's Award of Merit in qualifying. Failure to comply excludes that dog from obtaining official show champion title. Golden Retrievers that can not meet this minimum would be discouraged from breeding. This would help reduce the number of Golden Retrievers with little or no retrieving drive and desire. This type of measure has been incorporated in the United Kingdom to preserve the true Golden Retriever spirit.

Improve the Golden Retriever by putting social, political, and financial pressure on the AKC and GRCA to ensure conformation judges to advance only Golden Retrievers that do not have physical features that interfere with the breed's purpose, better retrieving.

Golden Retrievers with oversized skulls and excessive bone are clumsy and slow. These dogs take on the gracefulness of a Saint Bernard when working on a retrieve. When working in high cover or a long water swim, these dogs demonstrate no finesse, style and stamina due to muscle fatigue on account of their thick bone frame. Their coats are so long and thick, similar to a Collie, it impedes faster motion.

If effective changes do not stop the destructive path the Golden Retriever is on, then it might be time to separate the AKC breed. Any Golden Retriever that is a proven field retriever should be called "Golden Retriever." Any dog bred for the new alternate standard should be referred to as simply a "Golden".

YANKEE Breeder Referral

Breeder Referral Listing & Newsletter Listing Policy

ANKEE GOLDEN RETRIEVER **CLUB** offers the Breeder Referral as a service to member breeders, stud dog owners, and prospective puppy owners. Acceptance of a listing does not guarantee placement of puppies, and does not constitute endorsement by the club or any of its members. Neither the club nor its Board of Directors assumes responsibility for the quality, health, soundness, or temperament of any litters listed. **YANKEE** recommends that a fully executed, written purchase agreement setting forth all the terms of purchase be obtained before possession of a puppy is transferred to a purchaser. YGRC members may list litters, older puppies, and adult dogs with the Breeder Referral Listing and in Finish Lines if the breeder/stud dog owner has been a member of **YANKEE** or another GRCA-member club for a minimum of one year, and submits the following:

• Copies of AKC registration certificates, thereby verifying that both the sire and dam were over 2 years old at the time of breeding.

• Eye clearances on both the sire and dam, issued by a veterinary ophthalmologist who is certified by the American College of Veterinary Ophthalmologists. Clearances must be current during the time the litter is listed. Eye clearances on dogs under 8 years of age are valid only for one year from the date of issue. CERF certificates will be accepted.

• Hip clearances on both the sire and dam. Dogs must have final OFA Certification or PennHip Distraction Indexes below the median done at or after 6 months of age, with no radio–graphic evidence of hip dysplasia.

• Final heart clearances on both the sire and dam, issued by a veterinary cardiologist who is certified by the ACVIM (Cardiology).

• A *Litter Listing Agreement*, completed and signed for each litter listed.

All listings and copies of clearances should be sent to the **YANKEE** Breeder Referral chair listed on the back page of this newsletter. Referral listings will run for 10 weeks; please contact the Breeder Referral chair to pull or to extend the listing. The listing fee is \$30 per calendar year or \$5 per older puppy or adult. Litters listed with the Breeder Referral service are automatically listed in the newsletter. Please note: **YGRC** members who own stud dogs may list letters sired by their dog when the breeder is not a **YANKEE** member, provided the same listing criteria have been met by both sire and dam.
