Report of the President

as presented at the YGRC annual meeting, January 24, 2004

elcome to the 2004 Annual Meeting of the YANKEE GOLDEN RETRIEVER CLUB. Let's give a round of applause to Donna Morgan and Melanie Porter, who managed all aspects of our dinner tonight, from this new, centrally located, and easily accessible venue, the good and affordable food, the trophy tables, and the terrific raffles, and so on. Everything has been great and looks lovely. Thank you.

After four years of YGRC's presidency, this is my last annual report. Looking back, I note that the years have gone by quickly, and I want to tell our incoming President, Jim Downar, that his new infant grandson will be walking and into mischief by the time his first year in office is completed. A lot happens in one short year. Aside from the old adage that the older we get, the faster the time goes —and we don't want to go there! — the time goes by quickly because YGRC is such a busy, multifaceted club.

This was another busy year for **YANKEE**, busy, successful, and satisfying. **YGRC** is one of the most active specialty clubs in the nation, and continues to be a leader among the many other GRCA member clubs. In 2003, we unanimously voted to donate an initial \$10,000 to the Zeke Cancer Fund, administered by the Golden Retriever Foundation, and to continue, on an annual basis, to make additional substan-

MEMBERSHIP

The application procedure to become a voting member of the YANKEE GOLDEN RETRIEVER CLUB is as follows:

- 1. Prospective members must attend two YANKEE meetings prior to becoming eligible for a full, voting membership. Club meetings are on the fourth Tuesday of oddnumber months, earlier in November, at the Acton Congregational Church. Copies of the Club Constitution and Bylaws will be available at each meeting.
- 2. A completed membership application, signed by two **YGRC** members in good standing, and the membership dues for one year must be submitted to the membership chair.
- 3. Upon completion of the membership requirements, the membership chair will present the application at the next Club meeting for a vote.

In the interim, if prospective members want to receive the **YGRC** newsletter, *Finish Lines*, they may do so as subscribers.

To become a subscriber, complete the front page of the membership application and send it with the subscription fee of \$15 to the membership chair.

Please note: Article 1 of the **YGRC** Bylaws states in part: During the month of November, a dues statement, payable on the first of February of the following year, shall be mailed to each club member. No members may vote who have not paid their dues for the current year. A membership will be considered as lapsed and automatically terminated if a member's dues remain unpaid 90 days after the first day of the fiscal year, *i.e.*, April 1. A \$10 late fee will be applied to any payments made after February 1.

Lapsed memberships are ineligible to vote, receive trophies, list wins in *Finish Lines*, list litters with Breeders' Referral, *etc.* To re-join the Club, the complete procedure described above must be followed.

From Right Field: Report from the Master National

[Ed. Note: The Master National Retriever Club is a national organization which holds an annual event to showcase the talents of hunting retrievers. The Master National hunt test is conducted under the rules of the AKC Hunt Test program. Many thanks to John Marchica who represented YGRC at the Master National and sent in this report.]



he 2003 Master National was held November 7-16 in Thomasville GA. Opening ceremonies at the Pebble Hill Plantation included an old time quail hunt with all the trimmings, including people dressed in period clothing, old guns for the quail hunt demonstration, and a horse-drawn wagon to carry the hunters and dog kennels. This was followed by the opening of the concession stand and, boy, was there a lot of stuff for sale!

Later, each committee leader explained the workers' duties and assigned shifts. The judges were introduced and each gave instructions and made some comments. Bill Ash from Region 1 noted that handlers should be in proper attire and when handling must direct the dog to the bird. Stewart McNames from Region 2 make some comments that were on the lighter side and reminded every one to have a good time. D. Blair Clark from Region 3 commented that the goal was to insure the test was fair and reminded everyone to have fun at the events. Jim Morris from Region 4 voiced a concern for line manners and wanted to emphasize that everyone was there to enjoy themselves with their dogs.

The Master National meeting was then officially called to order. A roll call of delegates was the first order of business. Wow, there sure were club representatives from all over the country. It was announced that the 2005 trial will be held in Palestine, Texas on the Big Woods Game Farm and that the dates for the 2004 event will be October 3-10, 2004 in Wisconsin. All directors for the open board positions were reelected. Results of the voting for the 2004 judges were: Region #1 John Marchica, Region #2 Alan Bruhin, Region #3

YANKEE GOLDEN RETRIEVER CLUB All Breed Agility Trials

Held in Conjunction with the Bay Colony Cluster Dog Shows, December 4-7, 2003

either snow nor wind nor unplowed parking lots can keep the YANKEE GOLDEN RETRIEVER CLUB from running successful agility trials!

This year's trials started out much as the previous trials have since 1998. A crew of **YGRC** workers showed up at Bayside Expo Center around 1:00 PM. on Wednesday, December 3 The sod was down and in the correct location — unlike 2001 when we had to cut and re-lay sod. Max200, our equipment

provider, arrived early, not having got stuck in the Big Dig traffic as they did in 2002. And the weather was beautiful if a little chilly. The only glitch was a big truck belonging to MB-F, the Bay Colony Cluster's show superintendent, was blocking the overhead door through which our equipment was supposed to come in and it wouldn't start. No problem: we unloaded the equipment in the parking lot and lugged it in through a side door. By the time we were just about done someone showed up and towed the truck away. With setup complete we were off to the hotel early. What a great way to start the trials.

The trials on Thursday December 4 and Friday, December 5 were *super*! Our judges, Greg Beck and Mark Sjogren, provided us with interesting, fun, challenging courses and the **YGRC** agility crew worked with their, now expected, usual efficiency to keep the trials running smoothly. Everyone had a great time! Some of us were even successful in competing with our dogs — just ask Mike Lappin.

Saturday morning December 6 we awoke at 3:30 AM. to a couple of inches of snow on the ground. On the weekend, we must complete the trials and be off the grass by 2:00 P.M. so the Cluster can hold the Groups and Best of Show judging on the grass. Therefore we have the first agility dog on the line at 6:00 AM. A little snow never stops us and we completed the day's runs and were off the grass by 1:30 PM

By the time we were ready to head home or to the hotels there was about a foot of snow on the ground. The restaurant, where we had reservations for our judges' dinner decided to close. So did most of the other restaurants in the area. Not ones to miss out on any opportunity to party we improvised by getting take-out and having our judges' dinner in the hotel lobby. Both Greg and Mark claimed it was the most fun they had ever had at a judges' dinner.

Sunday morning December 7 showed about 2 feet of snow in the unplowed hotel parking lot. The radio and TV reported that most of the major roads into Boston were plowed, but snow covered. By 4:30 a large contingent of **YANKEE** workers had gathered in the still unplowed parking lot to access the situation. By 5:00 AM. we had determined that the 4-wheel drive vehicles would proceed to Bayside while the vans, including the one we pushed to within fifty feet of the road and then stuck, would remain at the hotel to await the arrival of the snowplow.



Taking Judge Greg Beck with us, a caravan of workers made their way into Boston. We arrived at the Bayside to find another unplowed parking lot and a 6-foot snowdrift in front of the agility entrance. After a brief discussion with the Bayside staff several large pieces of snow removal equipment were dispatched to clear parking spaces and remove the snow drift so we could proceed with the trial.

By 6:30 AM. we were ready to run. Only 56 dogs decided not to compete on Sunday. Despite our late start we were off the grass by the 2:00 PM. deadline.

Yummy Salmon treats

One14.75 oz can of salmon, do not drain 1 sleeve of finely crushed saltine crackers (unsalted tops) or 11/4 cups flour

1 egg

Garlic powder (optional)

Mix the eggs and salmon, add the crushed crackers or flour, and garlic powder. Press into an oiled jelly roll pan. Bake at 350° until edges pull away from pan. Lower the heat to 225°, flip over the cake and bake until dry. Cut into bite sized pieces and store in the refrigerator up to 3 days or freeze.

2003 YANKEE Breeder Referral Report

his year a committee of volunteers met several times to review and update the breeder referral program. The goal of the committee was to see if we could improve the communication and education for prospective owners. Details will be included in an upcoming issue of *Finish Lines*, but the following are highlights of some policy changes that the committee recommended and that were approved by the Board of Directors.

 Stud dogs of YGRC members who have sired a litter to a non-YANKEE member's dam may now list that litter provided that the sire and dam meet the same criteria we have required in the past.

- Breeder referral reps may now give out the names of breeder reps from other Golden Clubs (with club's permission) when we don't have any litters listed.
- An ad will be taken out in the Boston Globe newspaper advertising the YGRC and our Web site. Update information/education on our breed and breeder reps will be located easily on the Web site.
- There will be a reduction on listing a litter. There will be a
 one time fee of \$30 for the calendar year or \$15 for listing
 just in *Finish Lines*.
- More people have volunteered to be listed as breeder representatives.

Neither the Club nor its of directors board responsibility for the quality, health, soundness, or temperament of any litters listed. YANKEE recommends that a fully executed, written purchase agreement setting forth all the terms of purchase be obtained before possession of a puppy is transferred to a purchaser. YGRC members may list litters, older puppies, and adult dogs with the Breeders' Referral Listing and/or in Finish Lines if the breeder has been a member of YGRC or another GRCA-member club for a minimum of one year, and submits the following:

- Copies of AKC registration certificates, thereby verifying that both the sire and dam were over 2 years old at the time of breeding.
- Eye clearances on both the sire and dam, issued by a veterinary ophthalmologist who is certified by the American College of Veterinary Ophthalmologists. Clearances must be current during the time the litter is listed. Eye clearances on dogs under 8 years of age are valid only for one

year from the date of issue. CERF certificates will be accepted.

- Hip clearances on both the sire and dam. Dogs must have final OFA Certification or PennHip Distraction Indexes below the median done at or after 6 months of age, with no radiographic evidence of hip dysplasia.
- Final heart clearances on both the sire and dam, issued by a veterinary cardiologist who is certified by the ACVIM (Cardiology).
 - A Litter Listing Agreement, completed and signed for each litter listed.
