



2011 MEMBERSHIP RENEWAL FORM

All YGRC memberships will expire on December 31, 2010. In order to keep your membership active, please submit this COMPLETED renewal form to the Membership Chair along with your dues, prior to February 1, 2011*. A \$10 late fee will apply after this date.

A membership will be considered lapsed and automatically terminated if dues remain unpaid, 90 days after the first day of the fiscal year.** Lapsed members receive none of the benefits of membership. No member whose dues are unpaid is allowed to vote at a club meeting, in accordance with Section 4-B of Article 1 of the Yankee Golden Retriever Club Constitution and Bylaws. If your membership lapses, you will be required to fulfill the Club membership requirements (attendance at two YGRC meetings and endorsement by two members in good standing) before you may be reinstated.

***New Yankee Members and Applicants** who have paid dues in September, October or November of 2010 are NOT required to submit payment of 2011 dues, but must return this completed renewal form.

****Renewal of Lapsed membership / Late fee:** A lapsed membership can be renewed after February 1 and before April 1 by paying the annual dues plus a \$10 late fee. **Lapsed members who renew but donot pay the late fee will have Subscriber status until the late fee is paid.** At the discretion of the YGRC Board of Directors late fees may be waived in unusual circumstances, upon written request.
