¹ A \$10 late fee will apply after January 1. Renewal of a lapsed membership / late fee: Lapsed members may renew after January 1 and before March 1 by paying the annual dues plus a \$10 late fee. Lapsed members who do not pay the late fee will have subscriber status until the late fee is paid. At the discretion of the **YANKEE** Board of Directors, a late fee may be waived if warranted, **ONLY UPON WRITTEN REQUEST**. Lapsed members receive none of the benefits of membership, and may *not* vote at club meetings (**YGRC** Constitution/ Bylaws, Article 1, Section 4B).

A membership will be automatically terminated if dues remain unpaid 60 days after the first day of the fiscal year (i.e. March 1). After March 1, members will be required to fulfill the club's membership application requirements (attendance at two **YGRC** meetings or helping at two club events, and sponsorship by two members in good standing), with a vote at a regular club meeting, before being reinstated.
